# Board Vacancy Process "Application for Board of Directors" Instructions"

The following instructions and information are provided as a guide to you in determining your willingness to serve, the filing of your application, the conditions that apply to your eligibility to serve and what is expected of you as a member of the board of directors if so elected.

## 1) Conditions of application

- a) Election to the boards of directors of the Trapp Family Housings Cooperatives is accomplished through election by shareholders at its annual spring meeting.
- b) Upon the resignation and or demise of a standing member of the board of either cooperative, the remaining members of that board may appoint a new member to fulfill that members remaining term.
- c) The election and term of office of the boards of director's members is governed by the by-laws of the cooperative.
- d) Board member and spouse expenses are covered for approved events including, but not limited to, semiannual board meetings as follows:
  - a. Housing accommodations, duration of stay to be approved by Board President
  - b. Meals, as deemed appropriate and approved by the Board President
  - c. Travel expenses reimbursed at the mileage rate for automobile use established by the IRS for tax purposes for a maximum of 1,000 miles round trip
  - d. Other approved events reimbursed as defined by the Board President
  - e. Incidental expenses associated with meeting preparation and or presentations
- e) It will be the prerogative of the board of directors in establishing the appropriateness of a prospective candidate to institute a criminal record check and or any other character inquiry of public record it deems necessary for the protection of and in the interest of the shareholders to whom it is beholden. It shall be the responsibility of the board to protect and secure any and all information thus obtained.

### 2) Conditions of Service

- a) Applicants must attend all scheduled and special meetings of the Boards of Directors of the Cooperative
- b) Applicant must be willing to contribute time and effort as required on a working board including Task Group participation.
- c) Applicant must be willing to commit to a minimum of one three (3) year term
- d) Applicant must be so equipped and capable of communicating through the use of Email

## 3) Application Filing Instructions

- a) Complete the entire application. You may attach additional sheets rather than hand writing in the application using the headings as described in the application and a word processing utility such as Microsoft Word<sup>©</sup>
- b) It is helpful if Biographical information is chronological over the years you are describing.
